

HOUSE RULES

LEVI by City Takeover – Városligeti Műjégpálya

25 April 2026

1. Scope of the House Rules

These House Rules apply to all persons attending the LEVI by City Takeover event (hereinafter: the “Event”). By purchasing a ticket and/or entering the Event area, the attendee (hereinafter: the “Visitor”) accepts these House Rules as binding.

2. Admission and Tickets

Tickets are valid for one-time entry only. Tickets purchased online may be exchanged for wristbands where applicable. VIP and Backstage wristbands must be worn at all times and presented upon request. Damaged or invalid wristbands result in loss of access rights.

Standard tickets are valid until 23:30 and do not grant access to the after party. VIP and Backstage tickets are valid until 03:00 and include after party access.

Group tickets entitle six (6) persons to a single and simultaneous entry.

For time-limited tickets, arrival must take place by 17:30 on the day of the Event. In case of later arrival, the Visitor must pay the difference to the on-site standard ticket price.

The Event may only be attended by persons aged 18 or over. Valid identification may be requested.

For security reasons, bags and packages may be subject to inspection upon entry. No personal body searches will be conducted. Refusal of inspection may result in denial of entry.

3. Prohibited Items and Conduct

It is strictly prohibited to bring weapons, sharp objects, pyrotechnics, flammable materials, illegal substances, or any item that may endanger safety into the Event area.

Visitors under the influence of alcohol or drugs may be denied entry or removed.

No food or beverages may be brought into the Event area.

The use or possession of illegal drugs is strictly prohibited.

4. Venue Conditions

The Event takes place at Városligeti Műjégpálya. No ice surface will be present during the Event. Visitors must exercise due care when moving within the venue, particularly around temporary structures.

5. Cloakroom and Liability

No cloakroom service is provided. Visitors are responsible for their personal belongings. The Organizer shall not be liable for loss, theft, or damage to personal property, except where liability cannot be excluded under applicable law.

6. Reusable Cup System

A reusable cup system operates at the Event. The cup deposit is HUF 500 per cup and is refunded exclusively to a contactless bank card or mobile payment device upon return. Cash refunds are not available.

7. Photography, Recording and Image Rights

Audio and visual recordings may be made at the Event. By attending the Event, the Visitor acknowledges that they may appear in recordings.

The Organizer is granted a non-exclusive, worldwide, royalty-free right to use such recordings for documentation, reporting, and promotional purposes related to the Event. Visitors will not be identified by name without explicit consent unless permitted by applicable law.

8. Program Changes and Force Majeure

The Organizer reserves the right to modify the program. The Event may be altered, suspended or cancelled in whole or in part due to circumstances beyond the Organizer's control, including but not limited to extreme weather, safety concerns, or official authority decisions.

9. Compliance and Removal

Visitors must comply with instructions issued by security personnel and event staff. In case of violation of these House Rules, the Organizer reserves the right to remove the Visitor from the Event area without refund.

10. Governing Law

These House Rules are governed by the laws of Hungary. Any matters not regulated herein shall be subject to applicable Hungarian legislation.
