

## **HOUSE RULES**

Mahmut Orhan by City Takeover – Vajdahunyad Castle

12 June 2026

### **1. Scope of the House Rules**

These House Rules apply to all persons attending the Mahmut Orhan by City Takeover event (hereinafter: the “Event”). By entering the Event area, the attendee (hereinafter: the “Visitor”) accepts these House Rules as binding and agrees to comply with them.

### **2. Admission, Tickets and Wristbands**

By purchasing a ticket and/or entering the venue, the Visitor accepts the rules applicable to the Event. Tickets purchased via the webshop will be checked upon entry by the organizer, Festival Travel International Kft. (hereinafter: the “Organizer”), and may be exchanged for wristbands where applicable.

Tickets are valid for single entry only and are valid from 17:30 until 24:00. VIP and Backstage wristbands must be worn for the entire duration of their validity.

For security reasons, the Organizer is entitled to inspect bags and packages. Entry may be refused if the Visitor declines the security check.

The Event may only be attended by persons aged 18 or over. Valid identification may be requested.

### **3. Prohibited Items and Conduct**

It is prohibited to bring into the Event area any sharp or cutting instruments, weapons, pyrotechnic devices, explosives, items capable of causing alarm, or any object that may endanger the physical safety of others.

No food or beverages (including alcoholic and non-alcoholic drinks) may be brought into the Event area.

Persons under the influence of alcohol, narcotics, or other intoxicating substances are not permitted to enter. The possession or consumption of illegal drugs within the Event area is strictly prohibited.

### **4. Venue Conditions**

The Event takes place within the area of Vajdahunyad Castle. Due to the characteristics of the surface and temporary structures, Visitors must exercise increased caution when moving within the venue.

## **5. Cloakroom and Liability**

No cloakroom service is provided at the Event. Visitors bring and keep their personal belongings at their own risk. The Organizer shall not be liable for any lost, stolen or damaged personal property, except where liability cannot be excluded under applicable law.

## **6. Reusable Cup System**

A reusable cup system operates at the Event. The deposit fee for each reusable cup is HUF 500, charged at the time of purchase. The deposit will be refunded exclusively to a contactless bank card or mobile payment device upon return of the cup. Cash refunds are not available.

## **7. Photography and Data Protection**

Audio and visual recordings may be made at the Event. By attending the Event, the Visitor acknowledges that they may appear in such recordings. The Organizer may use these recordings for documentation and promotional purposes related to the Event in compliance with applicable laws, including the Hungarian Civil Code and the General Data Protection Regulation (GDPR).

The processing of personal data is governed by the Privacy Notice.

## **8. Liability and Force Majeure**

The Organizer reserves the right to modify the program. The Event may be partially or fully cancelled, suspended or interrupted due to force majeure circumstances, including but not limited to extreme weather conditions, official authority decisions or security risks. In such cases, the Organizer shall act in accordance with applicable law.

Visitors must comply with the instructions of security personnel and event staff, especially in the event of evacuation or other emergency situations.

## **9. Final Provisions**

In the event of a breach of these House Rules, the Organizer is entitled to remove the Visitor from the Event area. Matters not regulated herein shall be governed by the applicable laws of Hungary.
