

HOUSE RULES

Stephan Jolk by City Takeover – DOJO

10 July 2026 (Event)

1. Scope of the House Rules

These House Rules are binding upon all visitors (hereinafter: “Visitor”) of the Stephan Jolk by City Takeover event (hereinafter: the “Event”). By entering the Event area, the Visitor acknowledges and accepts the provisions of these House Rules as binding and undertakes to comply with them.

2. Entry, Tickets and Wristbands

By purchasing an admission ticket and/or entering the venue, the Visitor accepts the rules of the Event. Tickets purchased via the webshop will be checked by the organiser (Festival Travel International Kft., hereinafter: the “Organiser”) upon entry and may be exchanged for a wristband if necessary.

Admission tickets entitle the holder to a single entry and are valid from 22:00 to 05:00. VIP and Backstage wristbands must be worn visibly and continuously during their entire validity period.

Group tickets entitle five (5) persons to a single and simultaneous entry.

For time-limited tickets, arrival must take place by 24:00 on the day of the Event. In case of later arrival, the Visitor must pay the difference to the on-site standard ticket price.

For security reasons, the Organiser is entitled to inspect bags and packages. Entry may be refused if the Visitor declines to undergo security screening.

The Event may only be attended by persons over the age of 18.

3. Prohibited Items and Conduct

It is prohibited to bring into the Event area any stabbing or cutting tools, weapons, pyrotechnic devices, explosives, objects capable of causing panic, or any other items that may endanger the physical integrity of others.

No food or beverages (including alcoholic and non-alcoholic drinks) may be brought into the Event area.

Persons under the influence of alcohol, narcotics or any other intoxicating substances may not enter the Event area. The consumption of narcotic drugs within the Event area is strictly prohibited.

During participation in the Event, the Visitor must conduct themselves in a manner that does not endanger or infringe upon their own health or physical integrity, nor that of others.

4. Venue Characteristics

The Event takes place at DOJO (1051 Budapest, Zrínyi utca 4). Due to the characteristics of the pavement and temporary structures, Visitors are required to move around the venue with increased caution.

5. Cloakroom and Liability

No cloakroom service will be operated at the Event. Visitors bring and keep their personal belongings at their own risk. The Organiser shall not be liable for any lost, stolen or damaged items.

6. Reusable Cup (REPohár) System

A reusable cup system operates at the Event. The fee for a reusable cup is HUF 500 per piece, which will be charged at the time of purchase. Refund of the reusable cup deposit is only possible via contactless bank card or mobile payment method. Cash refunds are not available.

7. Image and Data Processing

Photographs and audio-visual recordings may be made at the Event. By participating in the Event, the Visitor acknowledges that recordings may be made of them and used by the Organiser for documentation and promotional purposes. Such use shall comply with the applicable laws, including the Hungarian Civil Code and the GDPR. The processing of personal data is governed by the applicable Privacy Notice.

8. Liability and Force Majeure

The Organiser reserves the right to modify the programme. In the event that the Event is cancelled, interrupted or partially held – including cases of force majeure (e.g. extreme weather conditions, authority measures, security risks) – the Organiser shall proceed in accordance with applicable laws.

Visitors must follow the instructions of the security staff at all times, especially in the event of evacuation or any extraordinary incident.

9. Final Provisions

In the event of a breach of these House Rules, the Organiser is entitled to remove the Visitor from the Event area. Matters not regulated herein shall be governed by the applicable laws of Hungary.
