

## House rules of Snowattack

### GENERAL RULES OF SNOWATTACK FESTIVAL & PARTY PLACES

By purchasing an admission ticket and/or entering the venue, you automatically accept the rules and regulations of the event.

In case you have purchased a Snowattack party armband, please present your voucher to the staff of Festival Travel when occupying the accommodation, so that you can redeem your armband. Visitors are obliged to wear their armbands at all times during their validity. Organizers will continuously check compliance with this at the entrance of party places. Visitors with invalid wristbands are required to leave the Party places.

### THE CAPACITY OF ALL PARTY PLACES IS LIMITED, SO PLEASE ARRIVE ON TIME!

Considering that Festival Travel provides the programmes and Services in cooperation with numerous Associates and depending on the performance of such Associates, Festival Travel shall not guarantee for the Visitor the availability, content, quality and quantity thereof (such as the performance of a certain artist, that the performance of a certain artist shall be according to the Visitor's expectations, or the opportunity to participate in a specific programme and/or at a specific venue), which however takes shape depending on the special characteristics of the venue and the equipments therein (like the holding capacity of a given venue).

For security reasons, organizers reserve the right to **limit the items and accessories that can be taken into the party places.**

In order to guarantee the safe conduct of the Event, the Organisers shall comply with the **French covid-19 and other legislation** in force in relation to the organisation and conduct of the Programmes.

Visitors are **not allowed to bring beverages**, whether alcoholic or soft drinks, onto the premises.

Visitor notes that Festival Travel, its contracted partners, contributors, media partners (in accordance with the provisions of the separate contracts applying to them), other Visitors and other third parties may make sound and video recordings at the events. Accordingly, Visitor expressly **consents to recording and publishing his/her face, appearance and manifestations**, with the condition that the publishing of his/her name is only possible upon his/her express consent.

The Visitor acknowledges that audio and video recordings of the Events may be made by Festival Travel and its authorised Contractors, Contributors, Press Staff (subject to the terms of their specific contracts), other Visitors and other third parties. In case Visitor is a public figure, publishing his/her name is possible even without his/her express consent. On recordings made as per the above, author gains unlimited, transferable and exclusive right to use with regards to the Visitor in time and space, as well as method of use. In relation to the Visitor, Festival Travel and any other persons authorized by Festival Travel have the right to utilize, use

(especially for advertising the Events), multiply, announce, alter, publicize and expose to the public, as well as market the recordings without having to provide any compensation to Visitor for this.

Contributors are allowed, where appropriate, to reserve equipment (e.g. speakers, guitars) that disturbs the rest of others for the duration of the Snowattack.

At the party places, Festival Travel ensures compliance with the behavioral and security regulations by **competitive and licensed professional partners**.

The consumption of drugs – in accordance with the effective laws – is also prohibited at the event venues.
